

Amendment No. 5 To Food Service Agreement Between Adair County Jail and CBM Managed Services This Amendment No. 5 (the "Amendment"), is entered into this 1 and 2 at 215 North Frankle Steek, Krisvalle, Masouri and Catering by Marin's, Inc. 4/6/a CBM Managed Services ("Contractor") located at 500 East 52." Street, North, Sioux Falls, South Dakota. WITHESSTH: WHEREAS, County and Contractor entered into a Food Service Contract (the "Agreement") dated November 1, 2013 for the management of the food service operation at Adair County Detention Center; WNEREAS, County and Contractor amended the Agreement previously via Amendment No. 1 dated May 14, 2013, via Amendment No. 2 dated October 6, 2014, via Amendment No. 3 dated July 27, 2015, and Amendment No. 4 dated November 1, 2015; WHEREAS, County and Contractor desire to extend the term of the Agreement for one (1) additional year to cover the period from November 1, 2016 through October 31, 2017 ("Extended Term"); WHEREAS, Paragraph 2.3 "Adjustments to the Contract" of the Agreement provides that after the initial contract year, the parties may adjust the contract pricing for future years based on the CPI (Consumer Price Index) "Food Away From Home Index" for the previous year; NOW THEREFORE, the County and Contractor lereby agree to amend the Agreement as follows: The Foregoing recitals are deemed substantive and are incorporated herein as if fully set forth. 1. Extended Term: County and Contractor agree to extend the Contract Term of the Agreement for one (1) additional year, effective from November 1, 2016 through October 31, 2017: 2.
