

**ADAIR COUNTY COMMISSION MINUTES  
WEDNESDAY, SEPTEMBER 25, 2013  
23RD DAY JULY ADJOURNED**

The Adair County Commission convened at 8:30 a.m. on September 25, 2013 in the Courthouse at Kirksville. All Commissioners were present.

The Commission attended a media event conducted by the United States Department of Agriculture (USDA). The event recognized the USDA's assistance to the Adair County Sheriff's Department in obtaining a grant to help purchase replacement vehicles.

The Commissioners discussed a budget amendment to create a new fund entitled "Inmate Prisoner Detainee Security Fund". This is in accordance to RSMo 488.5026 which states that a two dollar surcharge shall be assessed for all criminal cases..., funds to be deposited by the Treasurer to be used to acquire and develop biometric verification systems and information sharing to ensure that inmates, prisoners, or detainees in a holding cell facility or other detention facility or area which hold persons detained only for a shorter period of time after arrest or after being formally charged can be properly identified upon booking and tracked within the local law enforcement administration system, criminal justice administration system, or the local jail system.

Commissioner Adams motioned to approve the budget amendment with Commissioner Thompson seconding the motion. Presiding Commission Pickens was also in favor.

The Commission checked bridges on Horseshoe Way and Loral Lane; a complaint of vehicles parked on the right-of-way of Desoto Lane; and road conditions on Daytona Road plus various other county roads.

The Commission spent the rest of the day attending to County business.

The Adair County Commission adjourned at 4:00 p.m. on September 25, 2013.


