Mrs. Killday discussed funding for E-911. She stated that Missouri is the only state that does not have a tax designated for cell phones. There is a legislative push to put a statewide issue on the ballot to collect a monthly fee to generate revenue in order to repair or purchase E-911 equipment. Mrs. Killday stated that the current E-911 equipment will no longer be technically supported after September, 2017. Don Crosby is the appointee of the Commission to represent Adair County regarding E-911 issues.

Mrs. Macomber announced that the City of Kirksville will be placing an issue on the April, 2016 municipal ballot. The City intends to ask the voters to extend the sales tax that has funded the alternate route which bypasses the City of Kirksville. The final payment for the alternate route will be expensed in June, 2019. The tax is estimated to generate approximately 1 million dollars annually and will be used for roads, infrastructure, and economic development.

The road islands at vehicle intersections on Baltimore Street in Kirksville was discussed. The Missouri Department of Transportation (MoDOT) is no longer maintaining the islands due to funding cutbacks.

Mr. Moritz suggested a Christmas tree lighting ceremony on the Courthouse lawn in an effort to gather the Community together for the holiday season. It was suggested the event may be coordinated with the Kirksville Downtown Improvement Committee.

Discussion was held regarding a road that accesses a back entrance to Forest Lake. The Commission they haven't found any documentation that the road had been closed.

The meeting ended at 5:00 p.m.

The Adair County Commission adjourned at 5:00 p.m. on September 28, 2015.
