The Adair County Commission convened at 8:30 a.m. on September 4, 2018 in the Courthouse at Kirksville. All Commissioners were present.

At 9:00 am, the Adair County Commission met to approve discontinuing the burn ban in Adair County. All voted in favor of the motion. The burn ban was initiated on August 14, 2018.

At 9:15 am the Adair County Commission meet to approve a General Revenue Budget Amendment to create a revenue line item in General Revenue – Chemical Emergency Preparedness 101-4-000-600.975 and a corresponding expense line item 101-5-023-100.100 General Revenue – Health & Welfare – Chemical Emergency Preparedness both in the amount of \$2,749.01. 1st District Commissioner Bill King motioned to approve the General Revenue Budget Amendment; 2nd District Commissioner Mark Thompson seconded with Presiding Commissioner Stanley Pickens in agreement. All voted in favor of the motion.

This amendment will enable the County to receive money electronically deposited by the Missouri Department of Public Safety on behalf of the Adair County Local Emergency Planning Committee (LEPC) and then disburse to same.

The Commission wrote a letter to Adair County Prosecuting Attorney, Matt Wilson, asking him to research and give a legal opinion to the new phone fee as it pertains to RSMO 190.455. The information was requested by September 28, 2018.

The Adair County Commission adjourned at 4:00 p.m. on September 4, 2018.
