

**ADAIR COUNTY COMMISSION MINUTES**  
**WEDNESDAY, SEPTEMBER 5, 2018**  
**15TH DAY JULY ADJOURNED**

The Adair County Commission convened at 8:30 a.m. on September 5, 2018 in the Courthouse at Kirksville. All Commissioners were present.

At 10:30 am, the Adair County Commission met to approve A.T. Still University's use of the north parking lot of the Adair County courthouse for a September 11 Ceremony. 1<sup>st</sup> District Commissioner Bill King motioned to approve the use of the north parking lot for the ceremony; 2<sup>nd</sup> District Commissioner Mark Thompson seconded with Presiding Commissioner, Stanley Pickens, being in agreement. All voted in favor of the motion.

The Commission signed an Order to Transfer Funds at the request of the Adair County Sheriff's Department. The transfer requested funds from the Law Enforcement Services Account (301-5-001-400.000) in the amount of \$205,000.00 to the Law Enforcement General Account (801-4-000-700.200). This amount will cover salaries and accounts payable. This transfer will zero out the balance left for budgeted transfers between the two funds for the 2018 calendar year.

The Adair County Commission adjourned at 4:00 p.m. on September 5, 2018.
