ORDER DIRECTING NOTICE AND SETTING DEADLINES FOR INTERVENTION APPLICATIONS AND STAFF'S RECOMMENDATION

On March 30, 2022, Union Electric Company d/b/a Ameren Missouri filed the above-referenced tariff sheet proposing a revised fuel adjustment rate. The tariff sheet bears an effective date of June 1, 2022. Also on March 30, 2022, Ameren Missouri initiated a rate adjustment mechanism true-up to be included in the proposed fuel adjustment rate.

Commission Rule 20 CSR 4240-20.090 provides a 60-day timeline for resolution of these rate adjustment mechanism proceedings. The Commission will direct notice be given and set a deadline for intervention applications. The Commission will also direct the Staff of the Commission to file recommendations in both cases, as required by 20 CSR 4240-20.090.

The parties to Ameren Missouri's most recent general rate proceeding in which the Commission established, continued, or modified the electric utility's rate adjustment mechanism are automatically parties to these proceedings without application for intervention, pursuant to 20 CSR 4240-20.090(17). Thus, the parties to File No. ER-2019-0335 are parties to these cases.

THE COMMISSION ORDERS THAT:

The Commission's Data Center shall add to the service list all parties to File
No. ER-2019-0335 and shall provide them with a copy of this order.

2. The Commission's Data Center shall provide notice of this order to the Board of Alderman for the City of St. Louis and the county commissions for each county in Ameren Missouri's service territory.

3. The Commission's Public Policy and Outreach Department shall make notice of this order available to news media serving residents in Ameren Missouri's service territory and members of the General Assembly representing residents in Ameren Missouri's service territory.

4. Any application for intervention shall be filed no later than April 19, 2022.

5. No later than April 29, 2022, Staff shall file recommendations reporting its examination and analysis of Ameren Missouri's application and tariff sheet as provided by 20 CSR 4240-20.090(8) and (9).

6. Any response to Staff's recommendation is due no later than May 9, 2022.

7. Any response to Ameren Missouri's proposed fuel adjustment rate and/or proposed true-up amount from the Office of the Public Counsel and other parties shall be filed no later than May 9, 2022, as provided by 20 CSR 4240-20.090(8) and (9).

8. This order shall be effective when issued.
