ADAIR COUNTY COMMISSION MINUTES WEDNESDAY, SEPTEMBER 15, 2021 20TH DAY JULY ADJOURNED

The Adair County Commission convened at 8:30 a.m. on September 15, 2021, in the Courthouse at Kirksville. All Commissioners were present.

At 1:00 p.m., Commissioner Thompson moved to appoint Bradley Ray as their representative on the Adair County Joint Service E911 board. Commissioner King seconded the motion. Presiding Commissioner Shahan concurred. All voted in favor of the motion.

At 1:15 p.m., the Commission met with Kirksville City Manager, Mari Macomber; Public Works Director, Glenn Balliew; and Finance Director, Laci King, to discuss water levels for Hazel Creek reservoir.

First, Mrs. Macomber wanted to make sure that merchants would be notified about the Courthouse renovation ¼ cent sales tax going into effect on October 1. Adair County Clerk, Sandra Collop, said the Missouri Department of Revenue would be notifying each establishment affected by the tax increase.

Then, discussion was held regarding Hazel Creek. Water was being released and the level has decreased two feet. It is decreasing 1 inch per day or 5-8 inches per week. That is equal to a million gallons of water per day. They discussed time frames for replacement of the collapsed tube and how low the level needed to be. She thought the County could use American Rescue Plan Act (ARPA) money to fund the project. This is a primary, clarifying project and the city wants support from the County. It needs to be completed as soon as possible to provide additional water for the community. Mrs. Macomber stated the water tower stores four million gallons of water for 24-hour usage.

The Adair County Commission adjourned at 4:00 p.m. on September 15, 2021.
