The Adair County Commission convened at 8:30 a.m. on December 13, 2021, at their temporary office located in the records storage building at the Adair County Road and Bridge complex. All Commissioners were present.

The Adair County Commission met with Tim Shikles, Site Superintendent for Veregy, formerly known as CTS. Mr. Shikles presented a scope of work document for phase II of the Adair County Courthouse renovation. The document contained the work needed to complete the Courthouse. It didn't list specific bid prices for each trade. Mr. Shikles stated the electrical cost was approximately \$900,000, plumbing \$360,000 and communication \$210,000. He didn't have cost on anything else. The Commission requested an itemized bid for all work.

Adair County Clerk, Sandra Collop, reported she had received a Petition for Establishment of Speed Limit on Orrick Trail. She will check the petition signatures as all the residents must reside in the same township. The petition will then be returned to the County Commission.


The Adair County Commission adjourned at 4:00 p.m. on December 13, 2021.


