

**ADAIR COUNTY COMMISSION MINUTES
TUESDAY FEBRUARY 15, 2022
5TH DAY JANUARY ADJOURNED**

The Adair County Commission convened at 8:30 a.m. on February 15, 2022, at their temporary office located in the records storage building at the Adair County Road and Bridge complex. All Commissioners were present.

At 10:00 am, the Commission met with Jim LeBaron and Ron Stewart from the Adair County Health Department. The Health Department gave the Commissioners an update on their Renovation Project. The original project was to contain room for a community disaster shelter. Mr. LeBaron advised that they were no longer going have a room designated for a shelter. Instead, they were going to have a conference/training room in the building. It could still be used as a shelter if needed.

Mr. LeBaron stated the building would still be used as a storage shelter for the Health Department's 6 trailers. Mr. LeBaron stated that only two of the six are in a shelter at this time. Because of this, they have problems with their supplies getting either too hot or too cold. The building will also be used for drive-thru clinics.

Mr. LeBaron stated they needed this building because they will not always have access to other sites. He stated that the Crossing has been used in the past for walk-in vaccinations but would not always be available. Mr. LeBaron stated that the County Clerk could use the building for drive thru voting if she wished.

Mr. LeBaron asked if Adair County could give between \$50,000 to \$100,000 from the ARPA monies they have received. The money would be used to purchase equipment for the building to include furniture for the conference/training room and machines to filter the exhaust fumes for the vehicles.

The Commissioners were told the grant funding for the building was from the Missouri State Health Disparity Initiative. The State receives the grant money from the CDC. The Commission asked that the Health Department see if the grant allows for ARPA funding since both funds appear to be federal funds and the Federal Government does not usually allow two sources of federal funds to be used for grants. The Commission also asked for specific costs of any equipment they plan on purchasing.

The Adair County Commission adjourned at 4:00 p.m. on February 15, 2022.




IN REF. ORDER NO 7 Certificate of Training for Adair County 2nd District Commissioner, Mark Thompson


