### ADAIR COUNTY COMMISSION MINUTES MONDAY JANUARY 31, 2022 11TH DAY JANUARY REGULAR

The Adair County Commission convened at 8:30 a.m. on January 31, 2022, at their temporary office located in the records storage building at the Adair County Road and Bridge complex. All Commissioners were present.

At 11:00 am the Commission met with Shannon Howe, the engineer for the Hungry Hollow Road bridge. Mr. Howe had preliminary drawings for the bridge. The bridge will be sixty foot long and twenty-four foot wide. Mr. Howe advised the bridge would be put out for bid as soon as the final drawings were complete.

At 1:15 pm the Commission had a phone call with Howard Carter from Huber and Associates. Mr. Carter reviewed the status of the County's computer system. There was a server identified that still needed to be removed and the data moved to another County server. This would be completed after the Elected Officials move back into the Courthouse.

At 2:15 pm the Commission reviewed an ordinance to amend the current Equipment Lease Agreement. A motion was made by Commissioner Thompson to approve the ordinance. The motion was seconded by Commissioner Shahan. All Commissioners were in favor.

At 2:20 pm the Commission reviewed a petition to place a speed limit on Orrick Trl. And Cloud Trl. The petition was received at the Adair County Clerk's Office, on December 13, 2021 and they were able to verify the signatures of all but three of the residents through the voting rolls. A search through the Adair County Assessor's website verified the additional three signatures. The petition will be posted in three public places prior to its approval.

The Adair County Commission adjourned at 4:00 p.m. on January 31, 2022.
