ADAIR COUNTY COMMISSION MINUTES TUESDAY, OCTOBER 19, 2021 7TH DAY OCTOBER REGULAR

The Adair County Commission convened at 8:30 a.m. on October 19, 2021, in the Courthouse at Kirksville. All Commissioners were present.

At 10:00 a.m., the Commission met with Adair County Sheriff, Eldon Grissom; Danica Collinge, Administrative Section Chief/Financial Director; Senior Detention Officer, John Axsom; and Chief Deputy, Jason Lene, to discuss maintenance/repair to the jail. The Commission stated they had the opportunity to tour the jail yesterday to observe repair areas.

They stated the showers needed to be renovated and painted with a wipeable surface, the railing needed to be replaced to clean it better. Sheriff Grissom's goal was twofold – to make the area Covid compliant and to increase safety. Mrs. Collinge requested an application for American Rescue Plan Act (ARPA) funds. She thought the improvements would cost approximately \$125,000 and wanted to apply for ARPA money to finance the project.

The Commission stated that the County did not yet have the application process in place. They were unsure as to when it would be in place as they did not know if they would be financing big projects or many small projects. They will inform the Sheriff's department when the process is in place, and they are accepting funding applications.

At 1:00 p.m., the Commission met with Crystal Amini -Rad, Executive Director of SB40, to discuss and appoint a new board member. She stated that Beverly is leaving, and someone needed to be appointed thru June 24, 2022. Ms. Amini-Rad had organized a selection committee for the appointment. Presiding Commissioner Shahan complimented her on the process. At the recommendation of the selection committee, Commissioner Thompson moved to appoint Deb Wohlers. Commissioner King seconded the motion. Presiding Commissioner Shahan concurred. All voted in favor of the motion.

Discussion ensured regarding restructuring, turnover, fund raising, and applying for a grant with NEMO Connect. If awarded, they want to partner with social service agencies to help disadvantaged, make an online resource directory, partner with YMCA, and assist with an ATSU mentoring program. SB 40 is also in need of an accessible van.

Ms. Amini-Rad gave praises to the Adair County Public Administrator, Rhonda Noe, regarding programs for the wards. She invited the Commission to a retreat on November 6. The Commission thanked her for the information.

At 2:00 p.m., the Commission reviewed a website design and development contract developed by Vervocity from Quincy, Illinois. Margie Schlueter, Relationship Manager for Vervocity, had presented a proposal earlier at the Elected Officials on September 28, 2021. Commissioner Thompson moved to accept the proposal from Vervocity to design the Adair County website. Commissioner King seconded the motion. Presiding Commissioner Shahan concurred. All voted in favor of the motion. There will be a one-time investment of \$10,800 with a yearly investment for a licensing fee of \$200, and monthly hosting and security plan of \$79.00. The Adair County Commission adjourned at 4:00 p.m. on October 19, 2021.
