ADAIR COUNTY COMMISSION MINUTES **MONDAY APRIL 11, 2022** 4TH DAY APRIL REGULAR

The Adair County Commission convened at 8:30 a.m. on April 11, 2022, at their temporary office located in the records storage building at the Adair County Road and Bridge complex. All Commissioners were present.

At 10:00 a.m. the Commission reviewed an appointment to the Adair County SB40 Board. The position had been vacated by Latrisha Hicks. On the request of the Commission the vacated position had been posted for 3 weeks. Commissioner Thompson moved to appoint Dennis Miller to the vacated position. Commissioner King seconded the motion. All Commissioners voted in favor.

At 3:00 p.m. Commissioner King and Commissioner Shahan went to the Courthouse to review ongoing work. They left at 4:00 pm.

Adair County Clerk, Sandra Collop, reported official results for candidates and issues for the April 5, 2022, Adair County Municipal Election. They are as follows:

Question 1: Shall the Adair /County Ambulance District through its Board of Directors be permitted to increase from its current sales tax rate of three eighths of one percent (3/8%) to a sales tax rate not to exceed one half of one percent (1/2%). (An affirmative vote will ensure that property taxes for the Ambulance District remain at zero as mandated by statute). YES -1,196; NO -837.

School Board Members for R-2 LaPlata School District, Adair County (Vote for 2) were Jennifer L. Blacksmith – 26; Steven McHenry – 23; Steve Carvajal – 10; Tyler R. Hagar -1; and Write-ins 0.

School Board Directors for R-2 Brashear School District 3 Year Term, Adair County (Vote for 2) were Julie Hettinger - 96; Jessica Lunsford - 65; Leigha Mayfield - 54; and Write-ins -3.

School Board Directors for R-2 Brashear School District 1 Year Unexpired Term, Adair County (Vote for 1) were Donald Borgmeyer Jr. -102 and Write-ins undeclared -2.

Alderman At-Large for City of Greentop, Adair County (Vote for 2) were Ashley Robeson -6; Connie Halford -6; Jacob Justice -0; and Write-ins -0.

Alderman At-Large for City of Novinger, Adair County (Vote for 2) were Sharon Barnes -31; Derrell Kimball -26; and Write-in undeclared -1.

City Question for City of Novinger, Adair County (Vote for 1) was – Shall the City of Novinger continue the 35-cent tax levy on one hundred dollars valuation for General Municipal purposes for 4 years in the City of Novinger? (No Tax Increase) YES – 31 and NO - 5.

City Proposition 1 for City of Novinger, Adair County (Vote for 1) was – Shall the City of Novinger impose a local use tax at the same rate as the total local sales tax rate, provided that if the local sales tax rate is reduced or raised by voter approval, the local use tax rate shall be reduced or raised by the same action? YES – 25 and NO – 10.

City Proposition 2 for City of Novinger, Adair County (Vote for 1) was – Shall the City of Novinger impose a city sales tax of 1% on the receipts from the sale at retail of all tangible personal property or taxable services at retail, subject to the sales tax imposed by the State of Missouri (and on residential utilities) for the purpose of maintaining roads and general repairs to the city infrastructure? YES – 23 and NO – 12.

Board of Trustees for Village of Millard, Adair County (Vote for 2) were Amy Forquer – 5 and Write-ins – 0.

Ambulance Board of Directors for Adair Co. Ambulance Dist. 2, Adair County (Vote for 1) were Michael Robinson – 415 and Write-in undeclared – 1.

Ambulance Board of Directors for Adair Co. Ambulance Dist. 5, Adair County (Vote for 1) were David Kittle -277 and Write-ins undeclared -5.
