#### ADAIR COUNTY COMMISSION MINUTES MONDAY AUGUST 8, 2022 1ST DAY JULY ADJOURNED

The Adair County Commission convened at 8:30 a.m. on August 08, 2022, at their temporary office located in the records storage building at the Adair County Road and Bridge complex. Commissioner Thompson was not present.

Adair County Clerk, Sandra Collop, reported unofficial Adair County election results from the August 2, 2022, Primary. There was a voter turnout of 24.84 percent.

Note: County Question 1 for Adair County appeared on all ballot types. Results are listed at the end of the election results.

He said this was due to a data dump and he was not concerned about this either. On the ESS he stated that the employees need to do more training and they were working on getting everyone signed up. He stated that 40% of incoming emails were being blocked by the server. He stated that was a normal percentage. He said there were no issues with the silver scan. Overall, the system was secure. The meeting ended at 10:45.
