The Adair County Commission convened at 8:30 p.m. on July 27, 2022, at their temporary office located in the records storage building at the Adair County Road and Bridge complex. Commissioner Thompson was not present.

The two requests voted on were applications #5 & #6 submitted by Adair County. Request #5 was for \$386,620.00 for construction cost related to Hungry Hollow bridge project. Request #6 was for \$248,376.53, for upgrading the elevator at the Adair County Courthouse. Commissioner King moved to approve applications 5 & 6. Commissioner Shahan seconded the motion. Commissioner King and Commissioner Shahan voted in favor.

At 10:00 am, the Commission reviewed the applications for the SB40 board. They reviewed the applications from Donald Crosby, Tyson Treasure, and Julie Lochbaum. All three applicants are currently on the board and are up for reappointment. No other applicants were received by the Commission. Commissioner King moved to approve the reappointment of Don Crosby, Tyson Treasure, and Julie Lochbaum to the SB40 Board. Commissioner Shahan seconded the motion. Commissioner King and Commissioner Shahan voted in favor.

At 10:30 am, the Commission went to the Adair County Courthouse to review ongoing restoration and construction at the Courthouse. They left at 11:00 am.

The Adair County Commission adjourned at 4:00 pm on July 27, 2022.
