The Adair County Commission convened at 8:30 a.m. on September 13, 2022, at their temporary office located in the records storage building at the Adair County Road and Bridge complex. All Commissioners were present.

At 9:00 am, the Commission reviewed the Employee Assistance Program, which provided mental health assistance for the County employees. The added cost would be less than \$500.00 per year. Commissioner King moved to approve the additional assistance for the County employees. Commissioner Thompson seconded the motion. All Commissioners voted in favor.

At 1:45 pm, the Commission went to the Adair County Courthouse to review ongoing restoration and construction at the Courthouse. They left at 2:30.

At 3:30 pm, the Commission attended a joint ribbon cutting between the County and the City of Kirksville for the bridge over the Hazel Creek Lake causeway. Attending the cutting were the Commission, Adair County Road & Bridge Supervisor, J.B. Hamlin; Kirksville City Manager, Mary Macomber; Kirksville City Parks & Rec Director, Rodney Sadler; Kirksville Mayor, Zach Burden; Kirksville City Council members, John Gardner and Kabir Bansil; and Howe Company owner, Shannon Howe.


The Adair County Commission adjourned at 4:00 pm on September 13, 2022.
