At 10:30 am, the Commission went to the Adair County Courthouse where they observed the ongoing restoration and construction. They left at 11:25.


The Adair County Commission adjourned at 4:00 pm on September 20, 2022.

IN REF. ORDER NO 14 Resolution to Appoint Mark Shahan representative for Northeast Missouri Solid Waste Management

RESOLUTION TO APPOINT

WHEREAS, on July 9, 1990, Missouri Governor John Ashcroft signed Senate Bill 530, now known as Missouri's solid waste management law, which is designed to foster local government cooperation to reduce the volume of landfill solid waste in Missouri by 40 percent by 1998; and

WHEREAS, the **County of Adair** has joined its neighbor counties in establishing the Northeast Missouri Solid Waste Management District; and

WHEREAS, the governing body of each County within the district shall appoint two members of the County governing body to the solid waste management council and one member of the County governing body as an alternate;


