90-DAY PRESCRIPTION RETAIL BENEFIT

This benefit provides employees with the option to purchase a 90-day supply of their generic maintenance prescriptions instead of the standard 30-day supply.



There is one big advantage to purchasing the larger supply:

1. Cheaper refills. Though the copay on the larger generic refill usually costs the same or just slightly more than a standard 30-day supply, the 90-supply is cheaper per dose overall.

Not all prescriptions are eligible, such as narcotics or specialty medications Contact your pharmacy or CVS at 1-866-475-0056 to learn if your prescription is eligible

The next time you go to refill your maintenance prescriptions ask your pharmacy for a 90 day supply instead of the usual 30 day supply...you will pay close to the same price (or the same) price for a 90 day supply as you would for a 30 day supply!

Example: 1 month = \$45

It may sound to good to be true but it works for eligible prescriptions so ask your pharmacist today if your prescription(s) qualify!

LOCAL GOVERNMENT EMPLOYEES RETIREMENT SYSTEM (LAGERS) THREE WAYS TO ESTIMATE YOUR LAGERS RETIREMENT

LAGERS' benefits are designed to be a reflection of your working career. The longer you work, the greater your benefits will be. The amount of your benefit will be determined using a simple formula. LAGERS uses the same formula to calculate retirement, disability, and survivor benefits.



1) Old School-Pen to Paper Calculation:

The formula used to calculate LAGERS benefits is below:

Benefit Multiplier x How Much You Make x How Long Your Work

Benefit Multiplier

(Adair County is 2% or .02)

Χ

How Much You Make

(average of your highest consecutive 60 months (5-years) of salary from your last 120 months (10-years) of LAGERS credited service)

Х

How Long You Work

(vested in 5 yrs.-full retirement at age 60 for general employees and age 55 for law enforcement)

Monthly Lifetime Benefit (after dividing by 12 months)

EXAMPLE: An employee works for Adair County for 15 years and their average salary was calculated as \$30,500.

 $.02 \times $30,500 \times 15 = $9150/12 = $762.50 \text{ monthly lifetime benefit}$

2) Website Generic Calculator (no login required):

3) Member Online Portal Calculation (login required):

This is the most accurate way to estimate your retirement benefit. Just go to the Missouri LAGERS website at:

You will need to enter in your last name, first name, last 4 digits of your SS number, and your date of birth to get started.



County Employees Retirement System (CERF) Public Pension

CERF public pension benefits, just like LAGERS public pension benefits, are formulated based on years of service and salary. The longer an employee works and the more salary earned the greater the retirement benefits.

Once an employee becomes vested with at least eight years of continuous creditable service, they are eligible to receive a normal retirement benefit at age 62 or a reduced benefit at age 55.

Your benefit will be calculated using *three formulas":

- 1. Flat-Dollar formula
- 2. Targeted Replacement Ratio formula
- 3. Prior Plan formula

*The formula that produces the highest benefit is the one that will be used.

Calculating your possible CERF benefits, on paper, requires a little bit of time. To get an accurate reflection of your potential CERF pension benefits, it is better to call a CERF representative who will provide you with an estimated benefit statement. However, if you would like to calculate your own estimated CERF benefit by hand, then use the following three formulas:

All formula examples will be based on an employee working 15 years with an average final compensation (average of highest 2 years) of \$32,500.

The Flat-Dollar Formula:

\$29 x Years of Creditable Service (up to 29) X 2/3 (LAGERS participation reduction) = Monthly Benefit \$29 (flat rate) X 15 (years of service) = \$435 X 2/3 (LAGERS participation reduction)= \$290 Monthly Lifetime Benefit

Targeted Replacement Formula:

[(TRR x Average Final Compensation) - Primary Social Security Benefit] x Years of Service (up to 25) \div 25 Years + (1% x Average Final Compensation x Years of Service greater than 25 but no more than 29) X 2/3 (LAGERS participation reduction) \div 12 (months) = Monthly Lifetime Benefit

.80 (TRR) X \$32,500 (average salary) -12,000 (SS benefit) X15 (years of service) \div 25 (full participant years) X 2/3 (LAGERS participation reduction) \div 12 (months) = **\$467 Monthly Lifetime Benefit**

If your annual average final compensation (2 highest years) is	Your targeted replacement ratio (TRR) is
\$36,000.00 or less	80%
\$36,000.01 to \$48,000.00	77%

\$48,000.01 or higher 72%

Prior Plan Formula:

Average Final Compensation x 1.0% for LAGERS x Years of Service = Annual CERF Pension Benefit \$32,500 (average salary) X .01 (LAGERS participant multiplier) X 15 (years of service) ÷ 12 (months) = \$406 Monthly Lifetime Benefit

The formula that produced the highest benefit was the Targeted Replacement Formula which is a \$467 Monthly Lifetime Benefit for an employee working 15 years with an average salary of 32,500.
