### Newsletter Trivia Contest Winner

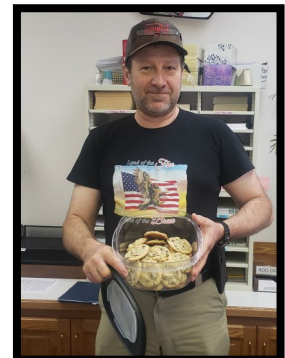
Thank you to those employees that entered the September 2022 Employee Newsletter Trivia Contest! All winning entries were placed into a random drawing.

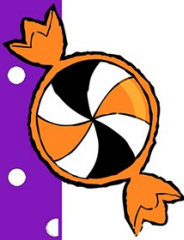
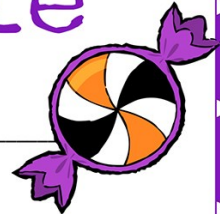
