The Adair County Commission convened at 8:30 a.m. on December 20, 2022, at their temporary office located in the records storage building at the Adair County Road and Bridge complex. All Commissioners were present.

At 9:30 a.m., the Commission opened bids for the construction of a bridge on Wilmathsville School Way. Present at the opening were Tammy Miller, Deputy Clerk, Adair County Clerk's office, Shannon Howe from Howe Company, and Maggie Merz, intern for Howe Company. There were three bids submitted for the project. The bids are as follows: C&C Bridge & Concrete -\$432,572.90; BRS Construction - \$323,935.50; Brookfield Box & Bridge - \$419,518.80.

At 10:45 a.m., the Commission reviewed a contract for Child Support Services for the 1st and 2nd Judicial Court Circuit. These services are performed through the Adair County Prosecuting Attorney's Office. Commissioner King moved to approve the contract. Commissioner Shahan seconded the motion. All Commissioners voted in favor.
