Tankless Hot Water Heaters

For the Adair County Sheriff's Office

Description

1. New tankless hot water heaters (2-3 units)
2. Tankless hot water heaters shall be designed and constructed for performance, durability, dependability, and safety
3. The tankless hot water heaters must work with our current system
4. The temperature shall be tested at the water outlets to make sure the system is providing the correct temperature
5. The bid will be all inclusive for the cost to install the unit(s) including any electrical work, etc.
6. Any hot water heater that cannot be repaired will be removed by the bidder even if it was unusable before they began this installation.
7. The bid will include a copy of the warranty.
8. The tankless water heaters will be installed at 215 North Franklin, Kirksville, MO 63501.
9. The bidder shall provide an estimated timeline to install the unit(s).
10. Any followup visits for ninety (90) calendar days after installation shall be included in the bid.
11. Bidder shall send proof of workmen's compensation and general liability insurance along with the bid.
12. All bids must be firm and fixed for ninety (90) calendar days.

The bid should be broken down as to the cost if two units or three units are installed

The bidder shall state if they are available for emergency calls for any repairs or servicing of the unit(s).

A site visit may be arranged by calling Chris Stivers, jail administrator, at 660-665-4644. There is no mandatory pre-bid meeting. It is the Contractor's responsibility to become thoroughly familiar with the site to successfully complete the installation and service.

Bid responses **MUST** be received by the date and time listed, any received afterwards will not be opened. Bids will be opened in the Adair County Commissioner's office in the Courthouse. You are invited to attend the opening of the bids. The County reserves the right to reject any or all bid responses.
