Description

1. NEW Vehicle – 2023 or newer police pursuit vehicle SUV
2. Vehicle shall be designed and constructed for performance, durability, dependability, and safety suitable for law enforcement travel.
3. Standard police pursuit vehicle with **Ready for the Road** type package equipment including but **not inclusive**
 - a. V6 engine
 - b. All wheel drive
 - c. Police tires & brakes
 - d. Underbody Deflector Plate
 - e. Spot Lamp
 - f. Global lock and unlock, hidden door lock plunger with rear door controls inoperable
 - g. Police engine idle feature
 - h. Radio noise suppression bonds
 - i. Vinyl flooring
 - j. Vinyl seats for 2nd and 3rd row
 - k. Red/White task lighting
 - l. Police wiring kits installed
4. The vehicle shall be outfitted with the required equipment as a complete package. All equipment shall be new OEM parts that conforms in strength, quality, and workmanship equal to equipment that is usually provided to the trade in general. It is the responsibility of the dealership to install any purchased packages and any equipment remaining from the packages shall be the property of the Adair County Sheriff's office.

5. The unit shall include all inspections, certifications and warranty identification cards furnished in accordance with standard manufacturer warranty policies. **The vehicle shall be properly serviced prior to delivery, including grease, oil, and fluids to the proper manufacturer recommended levels. This will also include a full tank of gas or \$75 gas card.**

6. The vehicle shall be delivered FOB Destination to 215 North Franklin Street, Kirksville, MO 63501 with Bill of Sale and Title of Ownership. The vehicle title address is Adair County, 106 West Washington, Kirksville, MO 63501.

All bids shall include a copy of the vehicle sticker or a list of included equipment and cost. The bids must be firm and fixed for ninety (90) calendar days after the RFP closing date.

Bid responses **MUST** be received by the date and time listed, any received afterwards will not be opened. The County reserves the right to reject any or all bid responses.

All Bids must be returned by November 21, 2025 4:00 PM. Bids will be opened in the Adair County Commissioner's office, date and time TBD (to be determined). You are invited to attend the opening of the bids.
